On the clinical side, incumbents will manage clinical services in an extended area of the province which promotes the provision of clinical services beyond the major metropolitan centres. Incumbents would be expected to apportion their time and energy appropriately between the major centres in the envisaged teaching/service platform (Durban, Pietermaritzburg, Newcastle, Empangeni and Port Shepstone). Incumbents will also develop research initiatives which focus on the enhancement of service delivery in the context of the burden of disease. Through this we will increase equality of service delivery, and enhance the development of our decentralised training platform in line with the needs arising from the National Development Plan.

Successful candidates without a PhD degree will be expected to obtain it within five years from the date of assumption of duty.
